

International mobility opportunities

Opportunities to :

- ✓ spend a **study** period abroad:
 - Erasmus+ Study Program
 - Overseas Program
 - Grant for research period abroad to prepare the thesis



- do an **internship** abroad:
 - Erasmus+ Mobility for Traineeships



Erasmus+ Study Program

The Erasmus+ Programme is an **EU funded mobility programme** promoting students' mobility in *Europe*

As an *Erasmus+ student*:

- you can carry out part of your University career (3 to 12 months) studying in another European country
- you can attend *courses*, sit *exams* and earn *credits* for your studies
- you will receive a grant to help you cover part of your costs
- you will be *exempted* from paying tuition fees at your *host university* (but not at your home university)

The Erasmus+ Study Call for application is published in January, every year



Erasmus+ Study: Where can you go?

- in any of the **26 European Union Member States**
- in the 3 countries of the European Economic Area: Island, Liechtenstein and Norway
- in the accession candidate countries: Turkey, the Republic of Macedonia;
- in some non-EU countries participating in the Erasmus+ Programme (e.g. the UK)

The list of partner universities is updated every year. It is available only once the call for application is published.

Who can take part?

 Anyone regularly enrolled at the University of Bologna (Bachelor and Master Students)



Erasmus+ Study destinations <u>supervised by STAT</u>



- 67 destinations
- 19 countries



Overseas

Overseas is an exchange programme promoting student mobility outside Europe


- The programme offers students the chance to attend courses and take part in research for dissertation purposes
- The University of Bologna offers a *grant* to cover some of the costs
- You can spend a semester or a full academic year abroad

Who can take part?

- Students enrolled in the <u>second year or above</u> of a Bachelor's Program or
- the first year or second year of a Master Program

Where can you go?

 You can spend time studying abroad in a university in 4 different continents: Europe, the Americas, Asia and Oceania (the partner universities include the University of California, l'Université de Montréal, Kansai Gaidai University, Universidad Nacional Autonoma de Mexico)



Study grant for research about final dissertation abroad

Who can apply?

Graduating students from Master Degree Programs at the Department of Statistical Sciences

Aims

Promoting research for the *preparation of the final dissertation*. A grant is provided to cover part of the costs abroad

How to apply?

Students must provide :

- A research project
- Approval by the UNIBO thesis supervisor
- A letter of acceptance from the hosting institution

The Call for application is published twice a year (in October and March)



Erasmus+ mobility for traineeship

This EU-funded programme gives the student a chance to carry out a **traineeship abroad** in any public sector company or a private commercial enterprise located in Europe.

Duration of traineeships: from 2 to 12 months

Grant: students will receive a EU grant up to a maximum of 3 months.

Where can you go:


- the 26 European Union Member States
- the 3 Countries of the European Economic Area: Island, Liechtenstein and Norway
- the accession candidate countries: North Macedonia, Serbia, Turkey.

Who can take part?

Students enrolled in first and second cycle degree programmes

The Erasmus+ Mobility for traineeships Call for applications is published in March every year
